

3Skill - Terms & Conditions

1. Introduction

Welcome to 3Skill. These Terms & Conditions ("Terms") govern your access to and use of our services, courses, internship programs, websites, and communications offered by 3Skill. By enrolling in any program, purchasing a course, or interacting with 3Skill in any official capacity, you agree to these Terms.

2. Payment, Fees & Pricing

- a. Current Program Fees (as of the Effective Date): - 2-Month Internship Program: ₹499 These prices are the program's standard fees and are subject to change. Any change in fees will be communicated through official 3Skill channels.
- b. Payment Partner: All payments and transactions are processed through our official payment partner Easebuzz. 3Skill does not accept direct bank transfers to personal accounts unless explicitly stated on an official invoice. Please verify payment links before making any payment.

3. Refund Policy

All payments made to 3Skill for courses, internships, or any other services are final and non-refundable unless stated otherwise.

However, an exception applies to the Internship Slot Booking Fee of ₹499, which is refundable under the following specific conditions:

1. The student has attended at least **75% of** the live classes conducted during the internship program.
2. The student has secured at least **60% marks** in the final examination.
3. The student has scored at least **60% in the basic** interview conducted at the end of the internship.
4. The student has secured at least **60% marks** in the final Project.
5. Final project submission is mandatory for all students. Failure to submit the final project will result in non-issuance of the internship certificate.

Only if all four conditions are met, the student will be eligible for a refund of the ₹499 Internship Slot Booking Fee.

Refund requests must be submitted within 7 days of program completion by emailing support@3skill.in with valid proof of eligibility. 3Skill reserves the right to verify the attendance, assessment and project data before processing the refund.

Refunds, if approved, will be credited to the same payment method used within 3-4 working days.

No other payments made to 3Skill are refundable under any circumstances unless required by law or explicitly agreed to in writing by an authorized 3Skill representative.

4. Code of Conduct, Misuse & Disciplinary Action
